Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2019-20 educational progress for Bronson Jr/Sr High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2019-20 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as NOT BEEN GIVEN ONE OF THESE LABELS'.

One of the biggest challenges we have is improving our graduation rate. It is still very high but it is lower in 2020 than it was in 2019. The rate in 2020 was 86.3% and the rate in 2019 was 94.19%. Because of the Covid 19 pandemic, we were unable to run our typical credit recovery term in May like we historically have. Not having class time in the spring of 2020, no doubt hindered some of our students opportunities to do credit recovery. Although some of our students still chose to work on credit recovery remotely, other students may have been hindered by this. Typically when we run an AER report, we have more data to look at but considering that all of the spring SAT, PSAT, and MSTEP assessments were cancelled last year the main thing we have to look at from last year is our graduation data.
